 expansion journey.
- 4. **Talent Development** Helping our community with talent building and development, working with members and educational stakeholders to expand access to talent and deepen the talent pool in Singapore.

During the term, I aim to focus on strengthening the value of the SFA membership, including building out a members directory and partner ecosystem to encourage product/services adoption and collaboration amongst members. I propose implementing enhanced accountability measures, such as annual ESG and transparency reports, to track SFA's impact and to build trust within the community.

I am committed to dedicating a third of my time, and more if needed, to ensure SFA's continued growth and success over the next two years.
